NCAA – “Do’s and Don’ts”

Secondary Infractions

Level II

- Inadvertent and unintentional violations not specifically listed as Level I
- De minimis in nature to restitution based, where eligibility is automatically restored upon the repayment of the value of the impermissible benefit to charity, where amount is less than \$100.00

NCAA – “Do’s and Don’ts”

Secondary Infractions

Level I

- Specific bylaws cited as Level I Secondary Infractions
- Intentional violations
- Similar repeat violations in the same sport in the same year
- Violations not isolated or limited to a single occurrence

NCAA – “Do’s and Don’ts”

Major Infractions

- An intentional violation had occurred
- A significant competitive or recruiting advantage may have been gained
- False or misleading information may have been reported to the institution or to the enforcement staff
- Reasonable Cause

NCAA – “Does and Don’ts”

Notice of Inquiry

- Advises the CEO of the undertaking of an investigation
- Indicates to the nature of the potential violations (including the involved sport), the approximate time period in which the alleged violations occurred, the identities of the involved individuals (when possible)
- Provides the approximate time frame for the investigation.
- Notifies the institution that other facts may be developed during the course of the investigation that may relate to additional violations
 - The enforcement staff does not publicly release the Notice of Inquiry
- Following the investigation, the NCAA staff provides the institution with a notice of allegations. The institution has the right to respond to the allegations to the Committee on Infractions
