
# Honor Code Revisions Update

- Fall referendum failed to pass communication issues
- Vote planned for February 23, 2009 along with Honor Council Elections
- Broader communication, town-hall meetings, website
- Revisions in organization of the code, easier navigation
- Language clarification lying, cheating, stealing definitions
- Clarification of procedures for reporting, investigating, conducting hearings
- Updated amendment process no referendum for procedural amendments

- Student moved home to VA Beach this semester to save money
- Students are talking more about financial stresses at home
- Changes in how students relax, leisure time
- Students unable to register due to financial holds on accounts
- International students (Korean especially) experiencing drastic decline in their currency's exchange rate
- Counseling Center seeing more individuals
- More students seeking emergency loans;
   depleted at the end of December

- Counseling Center when financial stress begins to impact overall functioning
- <u>Campus Ministers</u> for more spiritual and/or religious guidance in coping

#### **■** Encourage healthy and positive coping strategies

- Physical exercise Rec center facilities, classes, intramural sports, outdoors
- Talking to peers explore ways to help each other
- Eating and sleeping well for the endurance and energy needed to cope
- Meditation deep breathing and focusing exercises
