## HEADCOUNT ENROLLMENT REPORTING

HEADCOUNT STUDENT - A student enrolled for one or more semester credit hours. (See information on following page.)

LOWER LEVEL STUDENT - A student classified as freshman or sophomore.

UPPER LEVEL STUDENT - A student classified as junior or senior.

FIRST TIME GRADUATE STUDENT - A student who is enrolled at the graduate level for the first time; as defined by the U.S. Department of Education.

GRADUATE-FIRST STUDENT - A student enrolled in a masters degree program or a student enrolled in an advanced certificate or doctoral level program who has earned fewer than 30 semester credit hours of graduate level work.

GRADUATE-ADVANCED STUDENT - A student enrolled in an advanced certificate or doctoral level program who has completed at least 30 semester credit hours of graduate level work.

FIRST PROFESSIONAL STUDENT - A student enrolled in a program leading to the doctor of jurisprudence degree.

UNCLASSIFIED STUDENT - A student enrolled for course work, but not in a program leading to a degree.

The headcount enrollment, as reported in accordance with SCHEV policy, does not include non-standard course enrollment, i.e., enrollment in courses that are not a standard semester in length and have not completed 15% of their class meetings by the 14th day after registration for regular sessions. The exclusion of non-standard course enrollment results in fewer headcount students reported for the official headcount census than are reported for the end-of-term official FTE census. Since budget allocations consider FTE enrollment there is no monetary loss to the college as a result of the different reporting procedures.

It is important to give close attention to the data sources on the following enrollment summaries. The SDM and SCHEV Form B-3 reports have different census dates, and as stated above, the headcounts differ on the two reports. The B-3 is the official headcount enrollment report and excludes non-standard course enrollments; the SDM is the official FTE enrollment report and includes non-standard course enrollments. Usually the B-3 headcounts are presented in the data summaries; however, several of the enrollment tables present SDM headcounts to allow inclusion of all majors.
