WILLIAM LAMB DIARY - 1865

Sunday, January 15*

The fall of Fort Fisher. I was wounded in hip about 5 o'clk p.m. At 10 o'ck the Fort was surrendered.

Monday, January 23

Chesapeake Hospital, Fortress Monroe. Lieut. Parker U.S.N. obtained permission for me to stop here. Left Steamship California after dark, was admitted into Chesapeake General Hospital. John came with me.

Thursday, March 9

Surgeons Knolson & Rush examined my wound today & found two fragments of bone in my leg. They say they must be removed by an operation. Tolerably comfortable until wound was probed: caused leg to pain me 'till went to sleep.

Friday, March 10

Bad feelings until mid-night last night, better afterwards. Used anodynes. Recd letter from Daisy dated 6th; Ma recd one dated 7th. Recd a letter in afternoon from Daisy dated 5th. Recd letter from Adolpho Wolfe dated Feb 21st.

Saturday, March 11

Past a fair night without anodynes. Recd letter from Daisy March 8 & 9th. Had my wounded leg put into a cradle. It is comfortable.

Sunday, March 12

Suffered with colic nearly all night. Did not get through day very well.

Heard of Maj. Genl Whiting's death on the 10th It was a great shock to me.

Monday March 13

Passed a very good night. Liets Lewis & Howes C.S.A. moved from my room today back to theirs. Spent a good day. Got through last night very well. Recd two letters from dear Daisy dated 9 & 11th, and one sweet one dictated by my little daughter. Spent a very fair day, except effect of an injection. Dr. Knowlson has recd orders to go to Wilmington. I am very sorry. He has been attentive and kind.

Wednesday March 15

Had a very good night. Changed my bed today. Suffered severe pain all day and became very weak towards night took morphine & was relieved.

Thursday, March 16

Passed a good night under effects of morphine. Got some mint and had a nice julep. Passed a good day. wrote to Daisy.

Friday, March 17

Had a good night. Took one morphine powder. Dr. Knowlson bid me good bye as regular physician today & introduced Dr. Halleck.

Wounded leg ached at thigh severely & I took a morphine powder. Recd letter from Daisy.

Saturday, March 18

Passed a good night. Had a large flannel bandage put under my thigh. Passed a good day with assistance of anodynes.

Sunday, March 19

Very sick

Monday, March 20

(written 25th)
Very sick, many think I cannot live.

Tuesday March 21

Still very sick

Wednesday March 22

(written 25th)
My precious wife arrived today with Pa from Providence. I am better.

Thursday, March 23

Improving.

Friday March 24

Uncle Ned Simpson arrived from & left for Bridgeport today. Paleft for Providence.

Saturday 25

Changed my bed.

Sunday, March 26

Still improving

Monday 27

Latter part of the night first part suffered pain in wounded leg. Mr. I. I. Bloodgood of Norfolk called to see me. Spent a very fair night.

Tuesday, March 28

Spent a fair night by the use of anodynes. Drs. Rush, Halleck & Browen made thorough examination of my wound. found no bone injured. but broke an abcess.

Wednesday, March 29

Feeling very stupid from the effects of choloroform.

Monday, April 10

This morning about 12 1/2 a.m. news was recd of Lee's surrender, instantly drums were beat, every one woke & kept so till morning by music, speaking, & the noise of drunken men.

Daisy left for Washington to visit her sister Mrs. Dr. Porter.

Tuesday, April 11

Sent \$1 to T. Benton & Co. NG for six certificates in Gift Appreciation. as an amusement while on my sick bed.

Wednesday, April 12

Sent \$1 to Annandale & Co NG for five certificates in sale. Sent 25cts to JH Winslow for one certificate in jewelry sale.

Thursday, April 13

Precious Daisy returned from Washington. Sent \$1. to each of the following parties for certificates. Townsend & Co. & A.H. Rowan & Co., New York

Friday, April 14 - Good Friday

Dear Ma left for home. Purchased a copy of Richmond. Whig, published on a small double sheet.

Saturday, April 15

Heard of the diabolical assassination of President Lincoln, Mr. Seward & Son. I sincerely deplore the President's death

Sunday, April 16

No boat today from Baltimore.

Monday, April 17

Recd seven certificates from Annandale & Co. one from J. H. Winslow & five from Townsend & Co.

Recd a letter from Mrs. Chaffie. She is detained in Baltimore.

Tuesday, April 18

Sent \$2.30 to Annandale & Co. Send \$1.15 to J. H. Winslow & Co.

Wednesday April 19

Funeral of President Lincoln took place at noon in Washington. Recd five certificates from A. H. Rowan & Co.

Thursday, April 20

Sent \$3.42 to J. Townsend & Co. Sent \$2.30 to A.H. Rowan. Commenced taking Fowler's mixture.

Saturday, April 22

Took the oath of allegiance to support the Federal Constitution & laws, deeming further resistance useless & wrong & believing a life in prison could do no one good & that it would result in my death.

Sunday April 23

Recd a gold thimble from Winslow & co. Recd a ring & gold pen from Annandale & Co.

Monday 24

Daisy visited Norfolk today, Sat up today in a chair for the first time. Sat up about an hour without any ill effects.

Tuesday, April 25

Daisy returned from Norfolk. Sat up not quite an hour late this afternoon.

Wednesday April 26

Was carried into Daisy's room in my rocking chair & got a view of Hampton Roads & the shipping. Telegraphed Mr. Chaffee for him or Mr. Simpson to come after me this week. Sent app. to Genl Ord for permission for John to go North with me.

Thursday April 27

Sat up & went into Daisy's room again.

Friday, April 28

Recd two pencils & a brooch from Townsend & Co. Decordy came to see me.
Recd a box with my clothing from Providence.

Saturday, April 29

Dressed today for the first time since wounded & was carred down & sat on front portico for an hour enjoying sea breeze. Telegraphed Pa we would meet him in Balt. Tuesday.

Sunday, April 30

Visited Daisy's room

Monday, May 1

Left Chesapeake Hospital for my Rhode Island house. Assist. Surgeon Halleck accompanied me to Balt. Daisy was with me, with my servant John. Went in "Adelaide."

Tuesday May 2

Arrived in Baltimore & went to Barnums hotel. Left at night for New York in the 9.25 train & had a berth. Mr. Chaffee met us in Balt.

Wednesday May 3

Arrived in New York & left at 5 p.m. in Steamship Electra for Providence.

Thursday, May 4

Arrived in Providence this morning & was carried up home in a light wagon. A sweet home.

Friday May 5

An abscess has formed under my thigh where the other two were & it gives me great pain. Dr. Collins called & examined leg.

Saturday May 6

Dr. Collins performed an operation on me today opening the abcess under my thigh.

Monday May 8

Cash in hand. \$137.00. Will keep an account of expenditures & receipts from this date.

P.O. freight duty &c. on goods from England. \$80.

Wednesday, May 10

Wrote to Decordy & sent him \$35. return of money. Bishop Clark called this evening. My health improving rapidly.

Friday May 12

Wrote business letter of Decordy.

Wrote to Kahnweiler to come to the United States at once - wrote to Mike Glennan for my pipe.

Saturday, May 13

Wrote to Martin & Co. about check on Broadway bank - to A. R. Rowan & Co. about non receipt of articles.

Recd a letter from Jno. B. Lafitte of Nassau N.P. Daisy recd a letter from Maggie dated Warrenton, N.C., May 4th.

Sunday May 14

Heard with deep regret of the capture of Jefferson Davis.

Monday May 15

Maria went to school today for first time to Miss Minor.
Sat up for first time since I have been home. Went into Ma's room.

Tuesday, May 16

Recd a letter from Maggie, also one from Decordy. Daisy wrote to J. C. McArthur about the Lawrence draft. Sat up today. Dr. Collins examined my right leg carefully, thinks thigh bone is injured.

Wednesday May 17

Sat up today.

Friday, May 19

Wrote to Ed Lawrence & Co. Liverpool & to Decordy Daisy recd letter from J. C. McArthur in which he offers \$801. in gold for her draft for L 173.5.0. Daisy wrote to McArthur accepting & to Ed. Lawrence & Co.

Monday, May 22

Wrote to Mr. B. Lufilte under cover to Edw. Lawrence & Co. Liverpool. Recd \$3 from Daisy.

Tuesday May 23

Wrote to James Caskie, Esq., Pres. Bank of Virginia, Richmond, about the condition of the bank.

Wednesday May 24

Sat up much longer today than I have ever before.

Thursday, May 25

Received by Earle's Express from J. C. McArthur, New York, \$801. & 2 cts. in gold.

Mr. Chaffee deposited \$800 in gold for me as a special deposit.

Daisy the Sweetest woman in the world. Recd a letter from Mike.

He is in Norfolk.

Friday May 26

Dear Daisy has been suffering intensely with an abcess in her mouth. Pa & Ma visited Boston today. Gave Violet 65 cts to have Dick's hair cut &c. Box pills 50 cts.

Saturday May 27

Pa & Ma returned from Boston. Prescription 60 cts.

Tuesday May 30

Dr. Collins a Dr. from Lowell examined my wound. (Dr. Burmhamm.) Wrote to Mike Glennan in ans to his letter recd a few days ago. Had a pleasant call from Bishop Clark.

Sat up for the first time in several days. Was wheeled into the hall. 25 cts for soda. Ned Chaffee returned from Bridgeport. Recd my meershamm (sp?) pipe from Mike.

Ans. Mr. Leonard's letter. Dr. Collins thought he discovered a bullet in me today (morning). Dr. Collins brot. Dr. Carr (an old acquaintance) to see me. Further examination leaves impression that is piece of bone instead of bullet.

Recd two letters from father. One from Leonard & one from Taylor & Co. New York. Daisy, little Ria, Ria Porter & Pa got back from Plymouth, 9 P M to-night.

Sold \$700 in gold for 1.42 1/2. Proceeds, \$997. 50 cts.

Wednesday, August 23

Sent a draft from Old National Bk on Union National Bk of New York for \$600 to Norfolk. Wrote to father enclosing draft & \$3. Recd letters from Leonard in Norfolk & Dr. F.W. Potter, Wilmington. Wrote to Taylor & Co. New York enclosing \$20.

Thursday, August 24

Wrote to Mr. Leonard. Recd letter from Freeman Clarke, Comptroller of the Currency. Pills 25 cts. Sundries 50 cts.

Daisy recd a letter from Mother containing the sad intelligence that dear old Aunt Ria was dead. She died Thursday, Aug 31st aged 81.

Wednesday, September 6

Recd letter from Wilson.

Thursday, September 7

Wrote to Mother & recd a letter from her. Daisy went to Rocky Point with Dr. Porter & her sister & baby.

Friday, September 8

Recd letter from Mr. Leonard. Dr. Porter left for Washington. Pa, Ma, Ria Porter & Baby went to Rocky Point to stay a few days.

Saturday, September 9

Wrote to father. Recd letters from father, mother & Maggie.

Monday, September 11

Ria Porter came to town with Bessie to see the Dr. He thinks the baby in a very critical state. Wrote to Lawrence & Co. about a steamship line from Norfolk to Liverpool.

Tuesday, September 12

Recd letter from Kahnweiler (N.C.). Daisy & children went to Rocky Point.

Wednesday, September 13

Wrote to S.B. Kahnweiler. Recd letter from Peter C. Hull.

Dear little Bessie Porter died last night at midnight. Saw Mrs. Col. Brown. Had my hair cut.

Friday, September 22

Bessie Porter was buried in Swan Point Cemetary this afternoon. Was carried downstairs. Recd letters from father & from Taylor & Co.

Saturday, September 23

Recd letter from Decordy. Wrote to Mother. Drs. Collins and Porter examined my wound & think the substance found can now be extracted.

Sunday, September 24

Was carried down stairs & took tea in dining room. Today is the 15th Sunday after Trinity.

Monday, September 25

Drs. Collins, Carr, & Miller assisted by Surgeon Porter, U.S.A., performed an operation on me to day & extracted a large conical musket ball. It had particles of red woolen fibre attached to it - from the red flannel lining of my overcoat.

Tuesday, September 26

Received a letter from Mother & ansd it. Dr. Geo. Porter & dear sister Ria left for Washington Arsenal. Kahnweiler called en-route to night for a short time. Had a good night. I am feeling remarkably well considering the operation.

Wednesday, September 27

Slept unusually well. Gave Dr. Collins the ball he extract from me.

Thursday, September 28

Wrote to Maggie. Recd letter from Maggie. Recd ans from Col. Edw. Smith, AAG Richmond.

Friday, September 29

Recd letter from Leonard. Wrote to Kahnweiler. Got into my other bed & had mine made up Friday.

Saturday, September 30

Wrote to Leonard. Reading Abbott's Life of Napoleon.

Sunday, October 1

16th Sunday after Trinity.

Monday, October 2

Recd letter from dear father & from Wilson. Sat up during the morning in my chair. It effected my head somewhat. Daisy gave me a beautiful writing desk.

Tuesday, October 3

Recd letter from father containing information that I have recovered my moiety of the Argus. Wrote to father & Mr. Leonard. Authorized father to purchase Robert's lot for \$5,000.

Wednesday, October 4

Wrote to Mike Glennan & Geo. Tait. Recd letter from Taylor & Co.

Thursday, October 5

Recd letter from Edw. Allen, London & a returned letter sent to E.A. Kidden - New Bedford. Wrote to Silas Martin & Dr. Singleton & brother Rob.

Friday, October 6

Took a long ride with Pa, Ma, & Daisy past the Butterfly mill.

Saturday, October 7

Wrote to Kahnweiler.

Monday, October 9
