On Old College Property

Williamsburg Selected for State Court Center

Williamsburg has been selected as the permanent site for the National Center for State Courts.

The announcement was made in Washington recently by Edward B. McConnell, incoming director of the center and formerly director of administrative offices of the New Jersey court system.

Williamsburg was chosen over two other leading contenders, Denver and Philadelphia.

The center will be located on a 10-acre tract owned by the College, situated at the intersection of South Henry Street and Newport Avenue. Valued between \$500,000 and \$600,000, the property now contains the old Brown Building, formerly the medical-surgical center of Eastern State Hospital.

The General Assembly, during its last session, authorized the governor to approve the site under a long-term lease agreement at no cost.

Commenting on the selection of Williamsburg as headquarters for the center, Gov. Linwood Holton said that it is one of the nicest things that has happened in his administration as governor.

President Thomas A. Graves, Jr., announcing the decision in a recent communique to alumni of the Marshall-Wythe School of Law, stated, "This action represents the culmination of a two-year effort on the part of the College, particularly by the Marshall-Wythe School of Law under the leadership of Dean James P. Whyte, Jr., that began when the Center was first proposed by Chief Justice Warren E. Burger in March of 1971 during the National Conference on the Judiciary.

"It was the Chief Justice's hope that such a research center would become 'a national clearing house to serve all the states and to cooperate with all agencies seeking to improve justice at every level.' The two-year-old Center has a sixty-seven man staff headquartered currently in Washington, D.C. and Denver. To date, regional offices have been established at Boston, St. Paul, San Francisco, and Atlanta.

"Though the Commonwealth of Virginia and the Williamsburg community will derive considerable advantage from the Center's presence here, the greatest and most direct benefit will accrue, I am confident, to the College and to the School of Law. Many worked hard and effectively to obtain a decision in favor of Williamsburg. The leadership and continuing interest of Governor

Linwood Holton, Chief Justice Harold Snead, Justice Lawrence I'Anson, Judge Ted Dalton, Mayor Vernon Geddy, and Mr. Carlisle Humelsine have been especially important.

"I would also like to commend particularly Dr. William F. Swindler, whose early optimism infected us all, and Mr. Warren Heemann, Vice President for College Development, and his staff, who did such a fine job in preparing and presenting Williamsburg and the College's case to the Board of the Center.

"Our good fortune in bringing the National Center for State Courts to Williamsburg is an important and encouraging step in developing an even greater Marshall-Wythe School of Law."

Mr. Graves made similar announcements to the Board of Visitors, the Board of Trustees of the Endowment Association, the Board of Directors of the Society of the Alumni, the Board of Directors of the William and Mary Law School Association, the School of Business Administration Sponsors, the Alumni Chapter presidents and the Steering Committee of the Association of Parents.

He added, "On behalf of the College community, I would like to express our appreciation to those groups and individuals who worked so hard with the College to assure this significant achievement..."

IEAHC Marks 25th Year in Book Publishing

The Institute of Early American History and Culture is observing its silver anniversary of book publishing by preparing to issue several more significant studies of 17th and 18th century America.

The Institute, housed on the campus of the College, has, over the past 25 years, published more than 70 scholarly books, many of which have received national recognition.

Next year the Institute will issue the first volume in a 10-year-long project to publish the writings of Chief Justice John Marshall. Also scheduled for future publication are the complete works of Capt. John Smith, the leading founder of the Jamestown settlement, and a long-needed atlas of early American history. Financial assistance for these projects is being received from a variety of sources.

The Institute, which was founded in 1943, is sponsored jointly by William and Mary and The Colonial Williamsburg Foundation. It also publishes the

William and Mary Quarterly, a leading journal of early American history which dates back to 1892. Institute books are now published by the University of North Carolina Press and the *Quarterly* by the William Byrd Press of Richmond.

The College will hold summer commencement exercises Saturday, August 25, at 1:30 p.m. in Phi Beta Kappa Hall.

There are 298 candidates for degrees. James C. Windsor, president of Christopher Newport College, will make the major address.

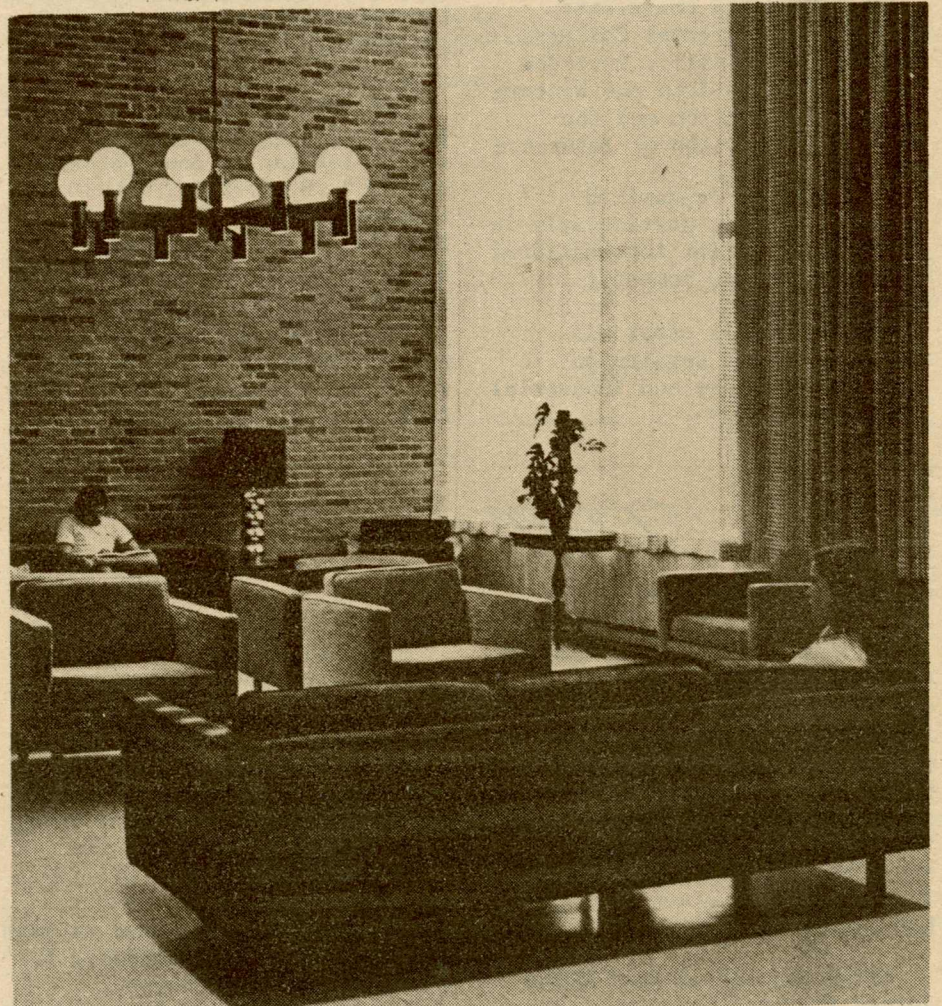

Board Member

Succumbs Aug. 12

William Holmes Trapnell, a member of the Board of Visitors and chairman of the board of Commonwealth Natural Gas Corp., died Sunday, August 12. He was 68.

Mr. Trapnell was a director and member of the executive committee of the Chesapeake and Potomac Telephone Co. and First and Merchants Corp. He also served as a director of the Richmond Corp. and Richmond Television Corp.

A past president of the Richmond Chamber of Commerce and a former director of the State Chamber, Mr. Trapnell has also served as a director of Richmond Memorial Hospital, the United Givers Fund, the Richmond Chapter of the American Red Cross, the Richmond Community Council and the Atlantic Rural Exposition.

A 1927 graduate of Hobart College, he has been a member of the executive committee of the State Council of Higher Education, chairman of the board of Richmond's St. Catherine's School and a member of the executive committee of the Virginia Foundation for Independent Colleges.

Chemistry

A paper entitled "A Light Scattering Study of the Hydrolytic Polymerization of Aluminum" by J. H. Patterson and S. Y. Tyree, Jr., appeared in the *Journal of Colloid and Interface Science*, 43, 389-98 (1973).

Economics

Francis W. Rushing, associate professor, presented a paper entitled "Technological Assimilation in the Soviet Chemical Industry" Thursday, August 16, at the 48th annual conference of the Western Economic Association.

The three-day conference, held at the Claremont Colleges in Claremont, Calif., included representatives from the Western Finance Association and the Western Association of Insurance Professors.

The program emphasized monetary policy, particularly in relation to recent international difficulties and domestic interest rates.

Mr. Rushing's paper was included in the session on "Market Structure and Industrial Organization."

Physics

Lynn Doverspike attended the 8th International Conference on the Physics of Electronic and Atomic Collisions in Belgrade. This trip was funded by the National Science Foundation and the government of Yugoslavia.

Mr. Doverspike presented an invited Progress Report entitled "Applications of Complex Angular Momentum to Atomic Scattering Problems." In addition he delivered a paper which he co-authored with J. Delos, R. Champion and S. K. Lam, entitled "Low Energy Collisional Detachment of $H^-(D^-)$ by Helium." He also served as chairman of one of the scientific sessions of the conference.

Employee's Contribution to VSRS

The recorded balance of contributions by each permanent full-time employee to the Virginia Supplemental Retirement System will be furnished semi-monthly with the employee's payroll check stub, effective with the pay period August 1-15, 1973. This new personnel service will enable each contributing employee to know on a semi-monthly basis just exactly how much money he or she has contributed to the VSRS towards his or her retirement.

If an employee does not agree with the recorded balance and can provide documentary evidence that the recorded balance is incorrect, such proof should be brought to the College Personnel Office so that a correction of the records (if appropriate) may be made.
