Execs Lecture Business Class

Six area business executives will serve as guest lecturers in the area of management at the School of Business Administration during the fall semester.

R. C. Walker, president of the United Virginia Bank of Williamsburg, will lead off the series which has been inaugurated as part of an undergraduate course in the principles of management taught by W. J. Maddocks, associate professor.

Walker will speak Thursday, October 17, on "Organizational Changes for Modern Banking."

R. Bares, Jr., vice president, Corporate Services for Colonial Williamsburg, Inc., will speak Oct. 22 on "Home-Grown Management Concepts."

"Labor Management Relations" will be discussed by J. B. Shea, general manager, Busch Properties, Inc., and brewmaster E. G. Martin of Anheuser Busch will discuss "Control of an Industrial Process," Nov. 26.

M. L. Barnett, director of manufacturing, Bendix Corporation, will speak to the class November 21 on "Control of a Manufacturing Organization."

The semester series will conclude December 5 with a talk by E. M. Cortright, director, Langley Research Center, NASA, on "Management of Large Research and Development Projects." "The speaker series," said Maddocks, "presents an opportunity to bring into the theoretical and academic make-up of the course a better balance of the real world of business and practical management." "It is also anticipated," he continued, "that the presence of those eminently qualified managers will produce a depth of inquiry and discussion not generally achieved in the traditional classroom environment."

E. C. R. Fawcett, director of public relations for the National Trust of Great Britain, will speak on "Victorian Gardens", Monday, October 14, at 2 p.m. in 101 Andrews.

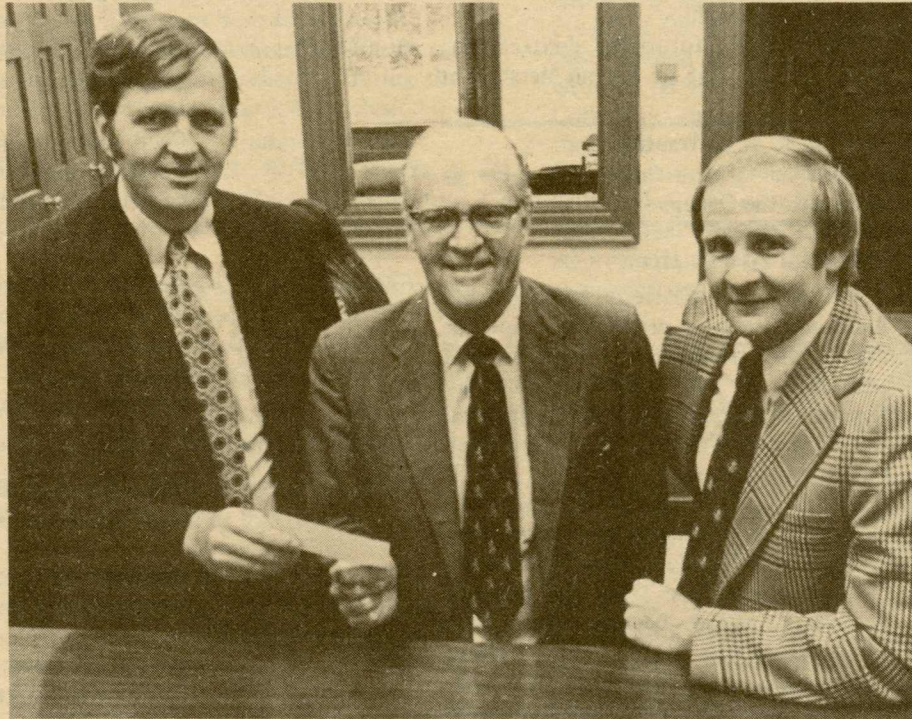
The public is invited to attend the lecture.

Law School Alumni Support Marshall-Wythe

James P. Whyte, Jr., dean of the Marshall-Wythe School of Law, recently accepted a check from D. Wayne O'Bryan, president of the Law School Alumni Association, donating \$44,126.86 to the Law School. At Dean Whyte's left is Sam Beale, president-elect of the Association. Funds for the donation were raised through the annual campaign conducted by the Law School Alumni Association. Forty-five percent of the donation, or \$19,857.10, will be used to help finance student loans. Twenty-five percent, or \$11,031.71, will be used for faculty research support. Twenty percent, or \$8,825.37, will be allotted to the Law Library. Ten percent of the donation, or \$4,412.68, will be contributed to Endowment.

W&M Theatre Tickets Available

William and Mary Theatre season tickets are still available for college faculty, staff and administration. The Theatre circulated its season flyer to the campus community at the beginning of this semester, but a number of inquiries indicate that the flyer was not distributed to all those interested.

The price for The Theatre's season ticket remains the same as for the last several years. A season ticket to the four productions of The William and Mary Theatre is priced at \$7. For those four productions plus the two visiting professional productions, a season ticket is \$12. Each season ticket represents substantial financial savings.

This year The William and Mary Theatre will present "Melody," an original drama by Michael B. Sullivan, directed by Professor Louis E. Catron, (Oct. 23-26); "The Beggar's Opera," by John Gay, directed by Professors Jerry Bledsoe and Stephen Paledes (Dec. 11-14); "Angel Street" (also known as "Gaslight") by Patrick Hamilton, directed by Professor Howard Scammon (Feb. 26-March 1); and "Much Ado About Nothing," by William Shakespeare, directed by Scammon (April 16-19).

The two visiting professional productions will be "Tom Swift and His ...," presented by The Dinglefest Theatre Company (Nov. 18) and "Concerning

Poor B.B.," a Brecht Collage presented by The Actors' Group (March 8).

All productions are in Phi Beta Kappa Memorial Hall. Curtain is 8:15 p.m.

The Theatre hopes all members of the campus community will continue the warm support which has characterized audiences ever since The William and Mary Theatre was founded in 1926.

Magnate Phones Forum Tomorrow

Kemmons Wilson, who in less than twenty-five years turned his idea for a comfortable but inexpensive motel into the multi-million dollar Holiday Inn chain, will speak via telephone hookup, to the students of Project PLUS during the third program of this year's Forum series, "The State of the American Dream."

The meeting, on Wednesday evening, October 9, at 7:30 in Millington Auditorium, is open to the public.

Listed by the London *Sunday Times Magazine* as one of the "thousand makers of the twentieth century" and described in the *Manchester Guardian* as the "all-American tycoon incarnate," Wilson, as chairman of the Board of Holiday Inns, Inc. and through his many additional enterprises, is involved in a number of businesses including Continental Trailways, the United States distributorship of the Japanese Subaru automobile, Delta Steamship Lines, a printing and office supply firm, the Holiday Press, Winrock Enterprises of Arkansas, and Continental Tours, a travel agency.

Wilson serves on the boards of Memphis State University and the University of Tennessee.

Scholar To Speak

Martin Kilson, dean of the Government Department at Harvard University, will speak on "Ethnic Groups in American Political Culture" October 14.

The lecture is scheduled at 8 p.m. in the Botetourt Theatre of Swem Library. Mr. Kilson's visit is sponsored by the United Chapters of Phi Beta Kappa as part of its Visiting Scholar Program.

In addition to his lecture, Mr. Kilson plans to attend five different classes October 14 and 15 in the departments of government, history and anthropology. Arrangements are being handled by the Government Department.

Mr. Kilson's fields of study include both politics and administration in developing African states and political patterns among urban blacks in the United States. He has authored several books including "Political Change in a West African State" and "Political Dilemma of Black Mayors." Mr. Kilson also has articles published in several journals including *World Politics*, *Political Studies*, and *Journal of Modern African Studies*.

After receiving his B.A. from Lincoln University in 1953, Kilson earned his master's and doctorate degrees from Harvard University in 1958 and 1959 respectively. He was granted a Ford Foundation fellowship for 1959-61 and a visiting professorship at the University of Ghana in 1964-65. He has been professor of government at Harvard University since 1969.

Subject: Implementation of the *Report of Self-Study*

In July, 1974, the Visiting Committee of the Southern Association of Colleges and Schools submitted its evaluation report on the College's ten-year *Report of Self-Study* that was completed in the early spring of 1974. The *Report of Self-Study*, together with the Visiting Committee's Report, provides the basis for the College now to begin the important task of considering the variety of significant recommendations that were in the Self-Study report.

Some of the recommendations of the *Report of Self-Study* have already been implemented or are in the process of being considered. Important examples are Long-Range Planning, and a Faculty Senate. The Long-Range Planning Committee, since it is established at a time when it can take full advantage of the Self-Study, will undoubtedly want to use the Self-Study as an important basis for its work.

Since there are a total of several hundred recommendations in the *Report of Self-Study*, however, it is essential that we develop a plan whereby during the 1974-75 academic year we give consideration to and reach an action conclusion on all recommendations.

Such action may lead to immediate implementation, further study, a recommendation for approval or disapproval to a higher authority, an agreement in principle but a delay in implementation due to a current lack of financial resources, or rejection for good reasons.

The effective review and implementation of the *Report of Self-Study* on a comprehensive basis is a high priority for the year. To this end I am asking the Vice Presidents to assume overall responsibility for consideration of and action on those recommendations that fall within his area of responsibility. A digest of the Self-Study's numerous recommendations prepared earlier this year by Jerry Van Voorhis, Assistant to the President, will be the basis by which the Vice Presidents, in the weeks ahead, will be seeking the assistance of many groups and individuals. Mr. Van Voorhis, because he has worked closely with the Self-Study, will be in a position throughout the year to receive and channel questions that may exist about the Self-Study.

Just as the *Report of Self-Study* involved the work of many individuals, its implementation will involve the contributions of many people. In this way I believe the Self-Study will fulfill the objective of internal self-renewal which has been an original and primary purpose of the *Report* throughout its nearly two years of preparation.

At the end of the 1974-75 session, I shall be asking the Vice Presidents to report to me in regard to what action has been taken. At that time we shall also want to report to the College community and to the Southern Association on the progress that has been made.

Subject: Use of telephones

The College has received two memoranda from George L. Hall, Director of the Virginia Public Telecommunications Council in the Governor's Office, in which Mr. Hall calls attention to the proper use of official State telephones. These points have been indicated from time to time in memos from this office, but here at the beginning of a new term might be a good time to repeat them, especially in view of Mr. Hall's notices.

First of all, personal long-distance toll calls cannot be charged to an official telephone. If an individual needs to make a personal toll call from such telephones, it may only be done by:

- (a) Charging to the individual's home telephone or credit card, or
- (b) Reversing the charge

College faculty and staff members are requested, however, to hold such calls to an absolute minimum, because of the time-taking procedures which must be followed by the College switchboard operators, thus reducing their overall operating efficiency.

A second advisory has to do with the use of SCATS lines. As most of you know, these lines are to be used for calling any telephone number in Virginia outside of our local area.

When calling another Virginia agency or institution, you should look up the SCATS number in the *State Telephone Directory* if one is available, or dial 369-4266 on the SCATS line and ask the SCATS information director for assistance. Do NOT use an area code when dialing a SCATS number. However, when calling another party in Virginia, who is not on the SCATS network, the area code must be used before dialing the regular 7-digit number.

Mr. Hall cautions that "henceforth agencies or institutions which incur long distance toll charges for *IN-STATE* calls... may be required to write a brief description of each such call and to submit the description to the VPTC for analysis." Such description would include the date, the time, the Virginia number called, the number from which the call was made, the identity of the caller, and explicit reasons why SCATS lines were not used to make the call. He points out that the burden of this reporting procedure can be avoided altogether if ALL in-State calls, outside the local area, are made on the SCATS lines rather than by long-distance toll facilities.

From a purely budgetary standpoint, all members of the College faculty and staff are urged to hold long distance telephoning to a minimum, at both the SCATS, as well as the out-of-state, level. Our SCATS bill totals some \$2,800 - \$2,900 per month, while the other long distance bills total \$1,900 - \$2,000 per month. Translated into annual figures, we are talking about more than \$56,000 per year for long distance calls alone! (This is an addition to the regular cost of equipment connected to the switchboard of some \$8,900 per month, or \$106,800 per year!)

We urge each of you, whenever you telephone, to consider carefully as to whether the call is really necessary and, if so, what minimum length of time the call should take.

At its meeting on September 27-28, 1974, the Board of Visitors approved the establishment of a new position of Vice President for Planning and Administrative Services, and directed me to take such actions as appropriate to fill this position.

Toward this end I have appointed a Search Committee to conduct a comprehensive search for candidates for Vice President for Planning and Administrative Services. This Committee is being asked to make recommendations to me of not less than three and not more than five candidates who are acceptable to the Committee, for my consideration and recommendation to the Board of Visitors.

The position of Vice President, as described in the resolution approved by the Board of Visitors, is as follows:

The Board of Visitors will, on recommendation of the President of the College, appoint a Vice President for Planning and Administrative Services. The Vice President for Planning and Administrative Services shall, under the direction of the President and in accordance with the policies of the Board of Visitors, work with all appropriate persons to develop integrated long-range plans for the College consistent with its statement of purpose and goals, and will coordinate the implementation of those plans within the resources available.

He shall have responsibility over the automated data processing resources of the College, for both educational and administrative purposes, and be responsible for institutional research. He shall take responsibility for a Collegewide management information system, for both current use and long-range planning. He shall have responsibility for the planning and administration of the College's space resources.

He shall take on such other administrative assignments as directed by the President, with the approval of the Board of Visitors. He shall, under the direction of the President, fill vacancies and establish new administrative positions, subject to appropriate approval and appointment by the Board of Visitors.

Subject: Affirmative Action: Faculty Salary Review

The review of all salaries of women holding full-time faculty or faculty-equivalent rank at the College has been re-opened this fall. The study will be made within the commitment to the merit system, which has been and remains the basic policy governing salary recommendations. Within that policy, the study will have as a principle aim the elimination of any possible sex-based salary differentials. The study will be completed no later than January 31, 1975. Any salary adjustments authorized as a result of this study will be made retroactive effective to September 1, 1974.

Subject: Confidentiality of Student Records

This is to bring to your attention two matters having to do with the confidentiality of student records. The College has been concerned for some time about insuring confidentiality of information about our students, and the College Self-study requested that special attention be given to this matter.

I. Honor Code and Disciplinary Penalties

Concern has been expressed about the fact that student Honor Code and disciplinary penalties appear permanently on the student's academic record card. This often involves a form of academic penalty for non-academic offenses; it also appears inconsistent to extend the penalty indefinitely through this exposure when the student is reinstated in good standing and is allowed to complete his academic work and receive his degree from the College. However, for certain purposes it is important that Honor Code and disciplinary records be kept in the student's permanent file. After a wide consultation on this matter, the following policy has been established:

"Henceforth, records of a student's Honor Code or disciplinary penalties will be expunged from the student's permanent academic record card when the student involved returns to the College and/or is reinstated in good standing as a student. It is understood, however, that such information will remain in the student's permanent file. The notification will not be expunged in cases where the student, suspended or dismissed, does not return to the College as a student in good academic standing.

"Upon request to and approval by the Registrar, faculty and staff may examine a student's academic record card (the transcript). Only the President, the Registrar, the academic Deans, and the Dean of Students will have access to a student's permanent file, unless written permission is given by the student involved for others to examine his or her permanent file."

II. The Posting of Grades

It has come to our attention that some instructors post course grades for public view. Many students regard this as an infringement on their right to confidentiality. To safeguard this right, it is important, when grades are publicly posted, that anonymity be preserved by the use of social security numbers or some other device.
