Avoid Risks Students Urged

In as many different ways as the Office of the Dean of Students and the Campus Police can devise, students are being asked "Use good common sense, do not take undue risks, use the buddy system when jogging at night and keep locked doors locked, don't prop them open."

W. Samuel Sadler, Dean of
Students, working with the Campus
Police Chief Richard Cumbee, has
initiated a number of measures to augment campus security and to allay
student concerns in the wake of recent
reporting of assaults and incidents of
indecent exposure.

Additional student patrol members have been employed to bolster existing patrols during the evening hours and provide security at several key campus bus stops.

Uniformed officers are being shifted to work as plainclothesmen for the next several weeks and to augment investigations. All available officers are being assigned from the day shift to evening hours

David Charlton, Director of Auxiliary Enterprises, has taken measures to insure that the campus buses stop at strategic campus locations on a precise schedule so that no one has to wait at these bus stops longer than absolutely necessary.

Student volunteers are being urged to reactivate the ESCORT service. In the meantime, campus student patrol members are escorting students upon request.

"This is a very deceptive campus," says Sadler. "There is immediate access and we are used to seeing visitors here. And for the most part we are very open, very trusting. I would hate to see conditions develop that would cause us to lose that openness, but we have to use some common sense and not take undue risks."

Sadler endorses the opinion of the campus police that the incidents are not related and therefore do not suggest a deterioration of the level of safety on campus.

Members of the residence hall life staff have been given guidelines for meetings with students both to answer questions about the incidents and to go over initiatives the College is taking. The guidelines include another reminder of the basic theme — "Don't Take Risks."

A pamphlet on sexual assault and assault prevention measures has been in the works and is being hurried along for distribution to students. Informal sessions on self defense are being planned by the Campus Police and a film on rape prevention is being shown in several residence halls. Faculty who

are teaching evening classes have been asked to suggest that students not walk alone to and from classes.

"We are trying to stress that nothing is effective if students don't help out by avoiding some of the risks that some of them are now taking. They are jogging

and bicycling alone at night and early in the morning, and residence hall doors are not being locked. These are simple measures and if they are done we will all feel a lot safer," said Sadler. "We don't want to be alarmist, but we must be concerned."

THANKSGIVING HOLIDAYS, 1981

The administrative offices, the plant department (except for those employees required to maintain essential services), and the mail room of the College of William and Mary will be closed on November 26 and 27, 1981. The Campus Police Department will maintain the regular 24-hour schedule.

The names of permanent classified employees who are required to work on either November 26 or 27, 1981 should be reported in writing to the Personnel Office in order that they may be credited with Compensatory Leave. Permanent classified employees who are required to work on either of these days should take compensatory leave earned as soon thereafter as possible in order to avoid excessive leave accumulation. Hourly employees who work on either of these days will be paid at their regular hourly rates.

CHRISTMAS HOLIDAYS, 1981

Again this year the College will observe an extended Christmas-New Year's Holiday period beginning Friday, December 25, 1981 through Friday, January 1, 1982. In the event the Governor declares an additional day or days, we would extend the beginning of the holiday period. As an example, if he declares one day, we would close at 5:00 PM on Wednesday, December 23, if he declares two days, the holiday will begin at 5:00 PM on Tuesday, December 22

Due to the nature of the service provided by the College of William and Mary, it is necessary that employees work on certain days which are listed as legal holidays in the Virginia Personnel Act. In recognition of this fact, the Board of Visitors of the College has authorized an alternate holiday schedule. The seasonal holiday noted above is consistent with that alternate holiday schedule, and it includes no holiday time over and above those total holidays authorized by the Virginia Personnel Act for all State employees.

The alternate holiday schedule adopted by the College provides for only five working days during this period. It will be noted that six working days are involved in the schedule described above. In order to provide the sixth day, we will utilize the holiday which falls on November 11, a Wednesday in 1981. Observance of this holiday for the Christmas-New Year's holiday period will remove the necessity to heat buildings and require employees to work one day during that period.

Administrative offices, and the plant department (except for those employees required to maintain essential services), will be closed during the period.

The Campus Post Office will be open from 9:00 AM until 12:00 noon on December 26,28,29,30 and 31, and January 1 and 2, 1982. If the holiday period is extended by one day, the Post Office will be open from 9:00 AM until noon on Thursday, December 24, 1981, in addition to the other dates shown. This Post Office will NOT be open at other times during the holiday period noted above.

The Campus Police Department will maintain the regular 24-hour schedule. The Switchboard will be open during regular hours each day, except for Christmas Day, when it will be closed.

Emergency service may be obtained at any time by calling the regular College telephone number, 253-4000, or by calling the Campus Police at 253-4596, or at Emergency Extension 333.

The names of permanent classified employees who are required to work during this holiday period should be reported in writing to the Personnel Office in order that they may be credited with compensatory leave. Permanent classified employees who are required to work on any of these days should take compensatory leave earned as soon thereafter as possible in order to avoid excessive leave accumulation. Hourly employees who work on any of these days will be paid at their regular hourly rates.

This holiday decision has been considered from many standpoints, since it is recognized that a few people might be inconvenienced by such a close-down over a continuous period.

Those individuals or groups who might be so inconvenienced by this extended holiday should direct their concerns to me, IN WRITING, no later that Friday, December 4, 1981, in order that we might make any special arrangements necessary to accommodate those concerns. In the absence of such notification it will be assumed that all offices are agreeable, and adaptable, to this extended closedown.

Please advise me, in writing, no later than Friday, December 4, if our assumption for those listed is not a valid one.

Employee morale constitutes one strong justification for the extended holiday. Another justification, of equal importance, is the fact that it enables the College to exercise effective energy and cost saving measures. We are under constant pressure on these points, and with the students away from the College, this holiday period affords the best opportunity of the entire College year for a virtual close-down of most facilities.

Paychecks for permanent employees will be available at the normal location (Payroll Office, 2nd floor, James Blair Hall) from 9:00 AM to 12:00 Noon only on Thursday, December 31.

The temperature in unoccupied buildings will be reduced to 50 degrees after 5:00 PM on Thursday, December 24th. This requirement will prevail through Sunday, January 3, 1982; if an additional day is declared by the Governor, this reduced temperature will begin at 5:00 PM on Wednesday, December 22. Buildings occupied during this period, are subject to the following schedules for temperature and lighting:

1. Student Residences

James Blair Terrace (Units 46,47,48 and 49), Corner House, Bozarth House, Hoke Garage, Bull House, Thiemes and graduate housing in the Randolph residences will not have reduced temperatures during this period.

Heat will be reduced in all other student residences after 12:00 Noon on Friday, December 18, 1981 through 8:00 AM on Sunday, January 10, 1982. Separate instructions to Area Coordinators and Resident Tutors will be issued by the Office of Residence Hall Life.

2. Offices

Brafferton, Rogers, Washington, and Millington Halls and the Population Laboratory will not have reduced temperatures during the period. Heating temperatures in the buildings connected to the Honeywell "BOSS SYSTEM" will be controlled by the "BOSS" operator during this period. Heat and lighting will be provided to the College Telephone Switchboard area and Campus Police Office at all times during the holiday break. Heat and lighting will be provided to the College Post Office from 9:00 AM to 12:00 Noon from December 26th throughout the holiday.

3. Libraries

Access governed by hours of operation established by the two libraries (Swem Library and the Law Library). However, heat, lights, and electrical devices in offices will be reduced according to the overall College schedule noted above.

4. Adair and Blow Gyms

Heating temperatures will be reduced and office lighting will be shut off at 5:00 PM on Thursday, December 17, and remain off until 5:00 PM on Sunday, January 3, 1982. Emergency and exterior lighting will be left on.

Savings last year from this holiday closing amounted to more than \$32,000, it is estimated conservatively that this year's schedule can produce savings of at least that amount. We are confident that, with your continued cooperation, such significant savings *can* be achieved without hardship or dislocation to our educational objective. We join you in looking forward to a well-earned happy holiday.

GUIDELINES TO REQUEST STATE POOL CARS

- 1) Submit Form WM8-1-4, APPLICATION FOR USE OF STATE OR PERSONAL MOTOR VEHICLE FOR OFFICIAL COLLEGE BUSINESS. (trip ticket), original and one copy approximately one week in advance to the Transportation Office.
- 2) Vehicles will be scheduled by the Transportation Office as the requests are received.
- 3) Trip tickets and vehicle key may be picked up and returned between 8 am to 4 pm weekdays at the Transportation Office. After 4 pm and weekends they may be picked up and returned to the Campus Police office.
- 4) Drivers must have a State of Virginia license.
- 5) Driver is responsible for recording the mileage at the beginning and end of the trip on the trip ticket.
- 6) Key and trip tickets are to be returned to the Transportation Office or Campus Police accordingly.
- 7) If necessary, credit cards to purchase additional gasoline are available in each vehicle.

8) In case of accident (regardless of the extent of damage) contact the State Police IMMEDIATELY.

Employee Selection Workshops Set

The series of workshops on exmployee recruitment and selection procedures scheduled to begin September 15 announced in the August 25 edition of the News.
