# New scholarship to fund student researcher

"There is an enormous sense of contentment in wanting to do something and being able to do it."

Thus Peter Neufeld '58 of New York sums up an elation that he feels very deeply with the establishment of a new scholarship, which honors two of the people who have had a growing influence on his life – the friends he made during his years as a student at the College.

Income from the permanently endowed Thomas Harland Llanso and Alan Clarke Sherman Scholarship Fund will enable a rising senior at the College, who has indicated an interest in medical research, to undertake an independent research program in one of the pre-medical sciences during the summer between the junior and senior years.

The first applicants for the Llanso-Sherman Scholarship will be screened this spring for award this summer.

The scholarship is named for two of Neufeld's friends who started college with him. Both died as young men. Llanso died as the result of a series of heart attacks that he didn't have the energy to fight because of the debilitating effects of diabetes. Sherman died after a gallant fight against Lou Gehrig's disease. Both men lived full lives despite their illnesses.

The scholarship, says Neufeld, "is a good way to make a small statement about all that."

Ask him who from his college days has influenced him the most and he will name the first director of the William and Mary Theatre, Miss Althea Hunt, and quickly adds, "the people who lived on the third floor of Monroe Hall when I was there."

Of Llanso and Sherman, Neufeld says, "They were the kind of friends who gave freely and unconditionally of their friendship."

The growing realization that his college friends have had a strong influence on his life has been a gradual thing, explains Neufeld. It is not one that surprises him. "It all seems quite logical," he says. "As we grow older, more and more things begin to come full circle."

currently playing in New York – "CATS," "Song and Dance" and "Precious Sons" – Neufeld enjoys sharing his knowledge with college students and will be back on campus in April to meet with theatre students.

Basically he tells them what they want to hear, the nuts and bolts of life in the theatre after college.

"Most of us were never more theatrical than when we were in college," he says. "When you earn a living in theatre you become less positive about everything, quite conservative and humble about it. . . . In other lines of work you develop gradually toward higher levels.



## Faculty-staff donate over \$12,000 to financial aid

Chairman Don Messmer reports that the Faculty-Staff Campaign total has now passed the \$12,000 mark. In only the second full week of the annual drive, response from the College community has been steadily forthcoming.

Student financial aid was selected as the campaign emphasis for a second year in order to focus campus attention on this critical need at William and Mary. Ed McCormick, director of financial aid, has indicated that without a significant infusion of new money into the College, the problem will only grow worse.

Uncertainty shadows the future of student loans with some cuts already being made and others being forecast down the road. Student employment opportunities, another major part of financial aid packages, do have limits and cannot be relied upon to make up deficits in assistance.

While resources either decline or remain static, costs increase. The issue then becomes one of keeping William and Mary a viable *choice* for those students already enrolled and for those qualified high school seniors hoping to

enroll. According to Messmer, "It is unthinkable that anyone should be denied a William and Mary education because he or she cannot afford it."

## Silesian Philharmonic invites Suben to conduct in Katowice

Joel Eric Suben, assistant professor of music, will guest conduct the Silesian Philharmonic in Katowice, Poliand, in a pair of subscription concerts April 3-4. Included on the program is the world premiere of a work by American composer Stephen Dembski. The Silesian Philharmonic is one of the nine major orchestras in Poland.

Suben, music director and conductor of the Peninsula Symphony since 1982, divides his time between the peninsula area and New York City where he has recently been named artistic director of a newly formed music festival in Brooklyn Heights.

A native New Yorker, Suben studied conducting with Jacques-Louis Monod, Otmar Suitner and Witold Rowicki. A former Fulbright Scholar in Poland, he holds degrees from the Eastman School of Music and the Hochschule "Mozarteum" in Salzburg and a Ph.D. from Brandeis University. In 1976 he was a finalist in the Hans Haring Conducting Competition of the Austrian Radio held in Salzburg.

Suben has served as conductor of numerous orchestras including American Symphony Orchestra in New York, the ROW Filharmonia and the Orchestra of the Katowice Conservatory in Poland. In 1985 he was invited to conduct the Queens Orchestral Society in New York. This is his third engagement with the Silesian Philharmonic.

# Bland Forum opens Feb. 9

Three ambassadors assigned to Washington, D.C., are scheduled to speak during April at Richard Bland College's eighth annual International Forum. Lectures are open to the public without charge and begin at 7:45 p.m. in Ernst Hall.

Carlos Tunnermann of Nicaragua will open the series on April 9. Subsequent lectures will feature F. Rawdon Dalrymple of Australia on April 16 and Padraic N. MacKernan of Ireland on April 23.

John Blair, originator and director of the International Forum, says that the speakers' visits will include meetings with the United States and World Affairs class and appearances before the Petersburg Rotary Club on mornings following the public lectures.

Ambassador Tunnermann, a native of Managua, accepted his current post Aug. 16, 1984. Previous trips to this country included those for observation and study of universities throughout South America and the U.S. in 1958 and 1961. He was awarded a Guggenheim Foundation Scholarship in 1974 to do a year's research at the U.S. Library of Congress to prepare a book on higher education in Latin America.

Ambassador Dalrymple began his U.S. assignment on June 24, 1985. A Rhodes scholar in 1952, he became a lecturer in philosophy at the University of Sydney until joining the Australian Department of External Affairs in 1957. In his 28-year career he has served throughout the world, including Indonesia, Germany and Israel.

Ambassador MacKernan, a native of Limerick, was educated at Sacred Heart College at Limerick University. He earned his master's at the University of Paris and entered the foreign affairs department as third secretary in 1964. MacKernan has served as Irish vice consul in Boston and deputy consul general at the Consulate General of Ireland in New York.

# Six major one-act plays highlight 'Second Season'

"Second Season," a theatrical arm of the theatre and speech department, will present six major one-act plays by wellknown professional playwrights, three plays a night on alternating nights, April 3, 4, 5 and 6 in the Studio Theatre of Phi Beta Kappa Memorial Hall.

Admission is free.

In a departure from the theatre's normal beginning time, curtain for all productions will be 7 p.m. Late arrivals may not be seated until an intermission between plays.

Students in advanced direction are directing the six plays. Earlier this semester the same students directed original monologues written by students in the theatre department's playwriting courses.

On April 3 and 5 the productions will be "Interview" by Jean-Claude van Itallie and directed by Ted Stark; "American Roulette" by Tom McCormack and directed by Andrew McRoberts; and "Sister Mary Ignatius Explains It All for You" by Christopher Durang and directed by Matt Del use

On April 4 and 6 the plays are "Stops Along the Way" by Jeffrey Sweet and directed by Linda Ruszler; "Canadian Gothic" by Joanna Glass and directed by Kevin Fink; and "American Modern" also by Joanna Glass, directed by Laurie Culpepper.

"These six plays are interestingly dif-

ferent, offering a wide variety of theatrical experiences for audiences, directors and performers," says Louis E. Catron, professor of theatre and adviser to "Second Season," who also teaches the play direction courses. "We run the gamut from a magnificently outrageous comedy – 'Sister Mary' – to a tightly knit, intense poetic drama – 'Canadian Gothic' – to an avant-garde experimental piece – 'Interview.' These six plays make exciting theatre."

So far this year "Second Season" has presented 25 plays. With these six, plus eight plays, which a beginning direction class will present on April 17, 18, 19 and 20, "Second Season" will have produced a total of 39 plays, 12 written by William and Mary playwriting students and the others by professional writers.

Catron, who attends rehearsals to critique directors and actors, offering suggestions and helping work out problems, says he is impressed with the quality of their work. "These actors and directors are aiming high," he says. "They've had a strong positive attitude about criticism, and they're all showing an eagerness to improve and do better. Their productions show a fine commitment to quality. This isn't a bunch of kids getting together in a barn to wing a show; these are people seriously interested in doing their very best."



# 1984-85 Grants and Research Report

#### 1984-1985 GRANTS AND RESEARCH HIGHLIGHTS

- \* Expenditures for research and instruction from public and private grants totalled \$6.4 million in 1984-85, a 33 percent increase over 1983-84
- \* Expenditures for externally sponsored faculty projects in arts and sciences, business, education and law were in excess of \$3.3 million in 1984-85, a 60 percent increase over 1983-84.
- \* This \$1.2 million increase in expenditures exceeds the total amount of \$1.05 million expended in 1977-78, when the Office of Grants Administration was reorganized.
- \* Externally sponsored research support at VIMS, after enduring three difficult years of program cutbacks, grew 11 percent in 1984-85.
- \* Federal, state and private grant support for academic programs is equivalent to an additional \$1,000 per student and represents 15 percent of the total Education and General Budget for the university.
- \* Approximately one-fourth of the university's faculty members received some support from external agencies for their research interests.
- \* Over 70 faculty members received compensation, including summer research salaries, from grants.
- Over 150 students received at least partial support from research grant funds.
- \* Indirect costs included in these awards provided \$239,000, or over half of the amount needed to support the Summer and Semester Research Grants programs:
- \* 32 faculty members received Summer Faculty Research Grants.
- \* 21 faculty members were awarded Semester Research Assignments.

These funds are a direct result of the initiative of the university's faculty members and their ability to compete on a national level for these awards.






