My dear Sir: I have been considering your offer of 30⁰⁰ per acre for your land - and have decided to take it at your offer, if you will make terms satisfactory - after I pay Jordan for his land, and buy stock for same, and the Short Corp. I find I will be short of funds. And I will make you this proposition, I will give you the \$30⁰⁰ per acre, $\frac{1}{3}$ in twelve months, and the balance in two years with interest on same, my son will endorse the notes and will give you a mortgage over the land. This ought to suit you as well as the work, as if you should need the money, you could get it on our notes & mortgage as we are worth more than two hundred thousand dollars above our indebtedness - and the buildings and improvements on the place would amount to a good deal, if you accept the offer let me know at once as I would have to put up the building and get things as I don't think I would pay Harries' negro debt - the interest on the money will amount to more than the rent and I should not pay this much for the land if I did not own land myself, I can look after both at the same time





which will be cheaper to be




board. you dont know how

The house & Barn is finished
& Cullen has moved all his possessions.
Farmer called to get the th 200⁰⁰ late Saturday eve
I told him he would have to give me a receipt
in full, but he said he could not do that as Cullen
still owed him th 37⁰⁰ & that he told you that he
take the th 200⁰⁰ & take his chances to get the th 37⁰⁰
I told him that Cullen had given me a mortgage
for you for th 200⁰⁰ on his two mules & cows & wagon
& buggy, & I had put it on file in Cleve's office
the day before, but since ^{then} I had heard that he
had not paid off given Ezell, Sanford a mortgage
on the same property, but I had not been able to see
him & ask him about it. (he said nothing to me
when he gave you the mortgage) & that I would
have to see him before I could pay him
so we hunted him up & he reckoned that he had
& paid all off but th 43.⁴⁸ & that Sanford

had agreed to wait on him for balance until fall
1913. I asked him why he did not say something to me about it
when he gave me mortgage for you - he said he did not
think about it. I told Mr Farmer I could not pay
him the $200^{\text{--}}$ then I would have to write you about
it. afterwards he phoned me that he ^{would} give you the
 $37^{\text{--}}$ in place of claim against Calle & Tasse $200^{\text{--}}$ in
full of all demands against Calle & Tasse. I replied
that I would submit the ^{concern} propositions to you & your
opinion the matter. I have inquired of Sanford
to find out for certain whether Calle had
it right, ^{or not} & he says it is $48^{\text{--}}$ dollars at
this time. I don't know what would be
the best for you, ^{to a} about ^{it} but I think if
Calle would give you a mortgage on
his house hold goods in fact every
thing he has got & pay of the claim
against Sanford of $48^{\text{--}}$ you would
have then every thing in your hands
you can use your own judgement, but
any way your claims on Calle would
be $237^{\text{--}}$ any way if you pay Farmer
the $200^{\text{--}}$ although the mortgage you have
is only for $200^{\text{--}}$, let me know at once what

sent for Terra-cotta. I don't know how deep
will have to go down but if we go 50 ft the

added to the above amount. I know you will
think this business has cost you a lot
money but I have done all I could do + James
has also + I hope you will except what has
been accomplished in good faith so you
see we will have to have $\$40^{\text{00}}$ more in addition
to $\$37^{\text{50}}$ if well is not more than 50 ft -
just as soon as I can get it all paid I will send
you bills + statement of the whole thing.



me know & I will send you my
note when I send the remainder of the

money left over. Calle has been cleaning
up the place preparatory to a crop & I believe
he intends in fact he said he is going to
do his best for a good crop. The well seems
to be doing all right, he said there is plenty ^{water} -
We have all been very much disturbed
over Jamie's misfortune. He was loading
some logs & had a needle in his belt & it
penetrated his shoulder & broke into & he
had to have an operation at the hospital
before it could be removed, & is at present
not able to do any thing & will be some time
unable to work. There is no special
news. The winter has been quite mild
so far with rains & clouds in abundance
I could have waited longer to write you
but I know your ^{impatience} expectation to hear
what I have done, I will write you
again before long, just as soon as
I can hear from you. We are all
in usual health, I feel rather shaky
some times but I try to do the best I can
All join me in sending love to you all.
